PRESIDENT'S REPORT

With gratitude I acknowledge that I live, and qathet Community Justice (qCJ) operates, on the traditional territory of the Tla'amin people. It is a privilege to write the second President's report for qathet Community Justice (qCJ) as we continue on our journey as an independent society.

qCJ has had another year of growth: in the number of cases; in the number of volunteers; and in the acceptance and awareness of the services we offer. We are proud to reflect on our referrals received through our Memorandum of Understanding with Crown Counsel and on our micro-credential course offering through Vancouver Island University, tiwšEmawtx^w campus.

Youth Restorative Action (YRA) at Brooks School continues to promote qCJ values and vision through presentations to students, teachers, parents and the School Board, as well as holding classroom dialogue circles. Over 500 youth have attended events or workshops, 14 new Circle Facilitators were trained, and 2 have received scholarships through our programming.

A huge thank you goes to our staff; qCJ Executive Director, the incredible Siobhan Brown, and qCJ Youth Restorative Action (YRA) Coordinator, the amazing Chelsea Friesen, for their efficiency and dedication to our organization. I am continually amazed at how much they achieve. We are also very grateful to the motivated and interested volunteers who embrace what we offer and give their time generously to take training, work on case teams, and on qCJ committees. We couldn't do this without you.







RESTORATIVE JUSTICE (RJ) CASEWORK










AREA of PARTICIPANTS*






AGE of PARTICIPANTS*

RJ CASEWORK OUTCOMES




PROCEEDED
